3. Save as provided in these rules, the fees paid for the grant of registration certificate shall be non refundable.
4. The rates of wages payable to building workers by the employer shall not be less than the rates prescribed under the Minimum Wages Act, 1948 (II of 1948) for such employment where applicable, and where the rates have been fixed by agreement, settlement or award, not less than the rates so fixed.
5. The employer shall comply with the provisions of the Act and the rules made thereunder.
